The person is telling you that you owe the IRS a certain amount of money and if you do not pay it you are going to jail. The person is speaking quickly and forcefully. The information they provide is vague but always comes with a threat.

This type of call is a scam that is very prevalent in our area and across the country. The IRS is not going to call you if you ow them money. They will inundate you with mail though. Should you receive this call take down the callers information along with whatever information is on your caller ID and send it to your local law enforcement office.

4 Business Financial Tips

Eric Siu recently contributed an article to Entrepreneur magazine related to the financial operation of business.

While finances are the lifeblood of a company, many business owners prefer the "ostrich head in the sand" approach rather than being proactive. Eric provides 4 tips to help the business owner.

- 1. Do Not Procrastinate. The longer that pile of receipts and invoices sits on your desk, the longer it will take to enter them. I suggest taking one day each week to tackle this task.
- 2. Understand Seasonal Cash Flow. Certain times of year are busier than others depending on the season or need of the product or service. Reviewing your finances from previous years can help identify when you need to be holding back spending.
- 3. Focus on your core strengths. I use this example all of the time. If you are a mechanic and are engine inclined, you probably do not want to spend time on Quickbooks. Hire professionals to handle the things you do not know so you can spend more time on your business.
- 4. If working 80 hours a week, you are not profitable. This goes back to hiring employees and contractors. We need to sometimes walk away to clear our head and get a clearer picture of our business.
